WORKS INSPECTOR (re-advertised)

The City of Mission is seeking a self-motivated, detail-orientated and experienced Works Inspector to join the Engineering & Public Works Department team.

This work involves performing a variety of regulatory and field inspections and associated duties related to sewer, waterworks, roadway, drainage and other public works construction projects performed for the municipality, including: ensuring conformance with applicable bylaws, regulations and other known standards; ensuring conformance with plans, specifications and schedules; attending pre-construction meetings; coordinating work between contractors, municipal crews and other agencies; monitoring volumes and quantities for release of security request; and technical field survey work in support of departmental activities.

You will have knowledge of the methods, practices, materials, tools and equipment used in the installations, construction and maintenance of municipal engineering services and facilities such as road works, curb, gutter and sidewalks; street lighting; traffic signals; sanitary and storm sewer systems; and water systems and other related services and facilities. You will also have a working knowledge of the methods, principles, techniques and equipment related to survey work, GPS, GIS and testing including related calculations in applying trigonometric and geometric formulas.

To be considered for this position, you will be a high school graduate (or equivalent) and you have completed some Public Works inspection courses. The ideal candidate will possess a Civil Engineering Technology Certificate or Diploma or you have an equivalent combination of training and experience. Completion of Construction Materials Testing Fundamentals, Public Works Inspection and Fundamentals of Surveying courses would be a definite asset.

You will have a minimum of two years' experience in inspection or public works construction (or recognized equivalent) and preferably you will be an ASTTBC Certified Public Works Inspector (CPWI); however, we may consider applicants without ASTTBC certification if you have the relevant education and job experience. You must have a valid Class 5 BC driver's license and Occupational First Aid Level 1 (or willing to obtain).

The hourly rate for this full-time CUPE position is \$38.57 or \$42.62 commensurate with the successful candidate's level of education, knowledge and experience plus a comprehensive benefit package including the Municipal Pension Plan and a commitment to ongoing training and career development. This position works 72 hours bi-weekly on a 4-day work week (9-hour shifts) either Monday to Thursday or Tuesday to Friday.
